SUBJECT: JURIS DOCTOR DEGREE APPLICATIONS GUIDELINES

- 1. The Legal Education Board (LEB) has approved the school's application to reissue diplomas, official transcript of records, and other academic credentials of Bachelor of Laws (Ll. B.) graduates from 2018 and prior.
- 2. The diploma conferring the Ll. B degree shall be substituted by the Juris Doctor (JD) degree pursuant to LEB Resolution No. 19, s. 2018 dated December 1, 2018.
- 3. The new JD diploma and transcript will be issued upon the request of the alumni/graduate after verification and validation with the records.
- 4. Steps to process the JD application:

- B. Clearance shall be processed by the Alumni Affairs Office with the concerned offices.
- 5. Once confirmed and cleared, the applicant pays the prescribed fees by coordinating with the Finance Office.
- 6. The deadline for registration is until November, 2023 or such date as the Registrar's Office may determine based on availability of its records.
- 7. Conferment Date will be announced after the lapse of the e-registration period.
- 8. The Registrar's Office—JD committee shall reply by email and post announcements on the AUSL website further updates, and for other details and/or information on credentials reissue and the graduation rites.
